

## **Categorized Government Entities**

(as of May 12, 2015)

The *Transparency and Accountability Act* (the Act), proclaimed in December 2006, provides for greater transparency and accountability of government entities to the citizens of the province. It requires all government entities (departments and public bodies) to prepare public performance-based plans and subsequent annual reports, which are tabled in the House of Assembly. As of May 12, 2015, the departments and public bodies noted below are categorized as government entities under the Act.
